## First Aid Kit Classifications

# A

### CLASS A KITS

Intended to provide basic range of products to aid most common workplace injuries such as minor cuts, abrasions, and sprains.

# B

### CLASS B KITS

Intended to provide broader range and quantity of supplies to aid injuries in more complex or high-risk workplace environments.

### OSHA 29 CFR 1910.151(b)

OSHA's 29 Code of Federal Regulations (CFR) 1910.151(b) requires that "Adequate first aid supplies shall be readily available." This rule applies to treatment of minor injuries that occur in the workplace. OSHA refers employers to ANSI Z308.1-2021 for guidance on minimum requirements for first aid kits.

### ANSI / ISEA Z308.1-2021

American National Standard Minimum Requirements for Workplace First Aid Kits and Supplies Z308.1-2021 establishes minimum performance requirements for first aid kits and their supplies that are intended for use in various work environments. Classification of first aid kits, designating the assortment of items and quantity of each item, is based on the anticipated number of users intended to be served by each first aid kit, as well as the complexity of the work environment and level of hazards.

### Section 6.4 | Antibiotic Application

Each antibiotic application shall meet the applicable requirements as defined in the current edition of USP/NF. Each application shall be packaged in individual-use, non-reusable applications containing at least 0.14 fl. oz. (0.5 g).

**Section 6.5 | Antiseptic**

Each antiseptic shall meet the requirements of all applicable FDA requirements and shall be contained in an individual-use, non-reusable application containing at least 0.14 fl. oz. (0.5 g) of antiseptic. (Note: Commonly used applicators are swabs and towelettes. Spray containers containing the minimum number of 1/57 oz. (0.5 g) applications required for Class A or Class B kits are acceptable to meet this requirement.)

**Section 6.7 | Burn Treatment**

Each burn treatment shall be a water soluble compound packaged in individual-use applications containing at least 1/32 oz. (0.9 g). (Note: Spray containers containing the minimum number of 1/32 oz. (0.9 g) applications required for Class A or Class B kits are acceptable to meet this requirement. Burn treatment, as required here, is intended to address the treatment of minor burns.)

**Section 6.14 | Hand Sanitizer**

Hand sanitizers shall be water-soluble with a minimum 62% ethyl alcohol as the active ingredient. (Note: Must contain a minimum of at least 1/32 oz. (0.9 g))
